

## **Skate Saskatoon Additional Measures for Skaters Nov. 2020**

1. The **NEW** Screening Questionnaire (attached) must be passed prior to entering the building every day.
  - a. This includes 5 new questions:
    - i. In the past 14 days, have you been tested for COVID-19 and are awaiting results for any of the following reasons:
      1. Due to symptoms,
      2. you are a close contact with a confirmed or probable case.
    - ii. Have you been tested for COVID-19 in the past 14 days without any symptoms or known exposures leading to the test, because you believe that although very unlikely it is possible you may have been in **non-close contact** with a confirmed or probable case of COVID-19, **and it has been less than 96 hours since your test.**
    - iii. In the past 14 days have you been directed by Public Health to self-isolate?
      1. Note, if, during the 14-day self-isolation period, you tested negative for COVID-19 and then were symptom free for 48 hours after the test, as well as being released from self-isolation by the Saskatchewan Health Authority this question is not applicable.
    - iv. Have you/your child or anyone in your household been in close contact in the last 14 days with someone who is being investigated or confirmed to be a case of COVID-19?
    - v. Have you had any symptoms of Covid-19 in the past 48 hours?
2. Random samples of the video monitoring system may be conducted to ensure physical distancing is being maintained and that all Skate Saskatoon protocols are being followed. If an individual (skater, parent, or guardian) is confirmed in contravention of the rules, the following consequences may result with no refunds or exchanges being granted:
  - i. 1<sup>st</sup> Offence (mild) – warning
  - ii. 1<sup>st</sup> Offence (significant) - 2-day suspension (Next 2 days of options purchased)
  - iii. 2<sup>nd</sup> Offence - 2-week suspension
  - iv. 3<sup>rd</sup> Offence - Seasonal Suspension
3. Skate Saskatoon Coaches are required to wear a mask that covers their mouth and nose at all times when inside the ACT facility. This agrees with the newly issued Public Health order (Nov. 3, 2020). Physical distancing is still required.
4. Athletes will continue with mask usage while not training but are permitted to remove their mask while training (it is still required during harness lessons).

## SKATE SASKATOON HEALTH SCREENING QUESTIONNAIRE

The answer must be **NO** to **ALL** questions to participate in any club activity.

1. Do you have a fever (a temperature of 37.8C or higher)?
2. Do you have any of the following symptoms:
  - a. Cough
  - b. Shortness of breath
  - c. Runny nose, sneezing or nasal congestion (not related to other known causes such as seasonal allergies, etc.)
  - d. Sore throat
  - e. Difficulty swallowing
  - f. Lost sense of taste or smell
3. **Have you had any of the above symptoms in the past 48 hours?**
4. Have you or someone in your household travelled outside Canada or had close contact with anyone that has travelled outside Canada in the past 14 days?
5. Have you had close contact in the past 14 days with anyone with a new cough, fever or difficulty breathing or a confirmed case of Covid-19?
6. **In the past 14 days, have you been tested for COVID-19 and are awaiting results for any of the following reasons:**
  1. **Due to symptoms,**
  2. **you are a close contact with a confirmed or probable case.**
7. Have you been tested for COVID-19 in the past 14 days without any symptoms or known exposures leading to the test, but because you believe that although very unlikely it is possible you may have been in **non-close contact** with a confirmed or probable case of COVID-19, **and it has been less than 96 hours since your test.**
8. **In the past 14 days have you been directed by Public Health to self-isolate?**
  1. Note, if, during the 14-day self-isolation period, you tested negative for COVID-19 and then were symptom free for 48 hours after the test, as well as being released from self-isolation by the Saskatchewan Health Authority this question is not applicable.
9. **Have you/your child or anyone in your household been in close contact in the last 14 days with someone who is being investigated or confirmed to be a case of COVID-19?**
